I, the undersigned, am a competent adult, residing in the United States of America, and, after due and proper consideration, having sought adequate counsel, do willfully enter into this legally binding Agreement that shall be interpreted and enforced according to the laws of the State of Maryland. I further agree to abide by all of the rules, restrictions, regulations, and requirements of the 2014 Capital Audio Fest DIY Amplifier Contest (the "Contest"), and believe my entry Amplifier (the "Amplifier") to be functionally safe and to conform to all such Contest rules, restrictions, regulations, and requirements.

As a Contest entrant (the "Entrant"), I further certify, swear, and/or affirm that I have personally built the Amplifier; and, if the Amplifier is not my own unique design, then either:

- a) I have permission to use the design and will credit the original designer, or
- b) the Amplifier design is considered in the public domain, and I agree to credit such original design.

On behalf of myself, my executors, agents, heirs, and assigns, I agree to abide by all Contest decisions of the Capital Audio Fest ("CAF") officials and/or Judges and further agree that:

- 1) CAF, it's officers, staff, agents, volunteers, and/or Judges, and their respective executors, heirs, and/or assigns are not responsible for any expense(s), damage(s) or injury(ies) that may be associated with this Amplifier in any way.
- 2) In addition, I agree to hold harmless CAF, it's officers, staff, agents, volunteers, and/or Judges, and their respective executors, heirs, and/or assigns for any damage(s) and/or claim(s) that I may have due to expense(s), damage(s), injury(ies), and/or the loss or theft of such Amplifier.
- 3) I agree to allow CAF to publish photos of myself and/or my Amplifier.
- 4) I am providing an accurate, complete, and legible schematic of the both the signal

circuit and the power supply of the Amplifier. In the event I am awarded first or second prize in the Contest, I authorize CAF and/or its sponsors to publish such Amplifier schematic for non-commercial use.

5) I agree that I, or my Designated Agent, will retrieve my Amplifier from the designated Contest retrieval area on or before 8:00 pm (Eastern time) Sunday, July 27, 2014.

In addition, if I initial below, I will be voluntarily appointing a Designated Agent, allowing such Designated Agent to act on my behalf for the purposes of facilitating my entry into the Contest. Such an appointment is my choice alone and I agree to hold harmless CAF, its officers, staff, agents, volunteers, and/or Judges, and their respective executors, heirs, and/or assigns for any loss(es), damage(s), and/or claim(s) that I may have due to my choice of appointing such Designated Agent.
